GUIDELINES, RULES and APPLICATION

SPACE FEE: One 10x10 is \$50, Two 10x10 spaces for the same vendor is \$80. Spaces will be assigned on a first received basis and acceptance is based on filling the spaces in your category. Priority is given to hand-made goods. No Plastic toy imports allowed. **Applications and booth fees must be received by June 28. Make your non-refundable, non-transferable check or money order payable to Tehachapi Valley Arts Association. Mail to: TVAA 100 W. Tehachapi Blvd. Tehachapi, CA 93561. OR Email gale67@gmail.com with your application and I will send you an invoice to pay by Credit Card through square, there is a \$5 convenience fee to pay by CC.**

DISPLAY SPACES: You **MUST** set up **INSIDE** your allotted space. Your booth must be manned during show hours which are from 9:00 am to 4:00pm. This is a juried show. All items you plan on selling must be included on your application or you will be asked to remove them. Failure to comply may result in you being asked to leave without a refund. Please do not break down early. Be sure to weigh down your canopy and equipment, the winds are unpredictable. Stakes of any type are not allowed in the park. You must use weights and appropriate display racks.

SETUP INFORMATION: Setup begins at 6am, events begin at 7:30 with the 5k run. We have to work around traffic issues dealing with the Run. Do not violate the marked off areas set aside for the run. There are usually crowds hanging around for the end of the run, so setting up early benefits you! You must be done with setup and ready to go before 9:00am at the latest. Unloading process: drive up, unload, move your vehicle, **THEN** come back and set up. Curb space for unloading is limited, please be considerate of other vendors who want to set up as well.

SECURITY: We are not responsible for loss or damage to your booth or its contents. Weapons of any kind are not allowed.

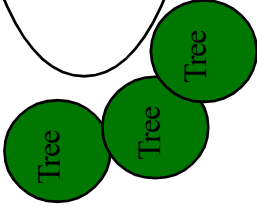

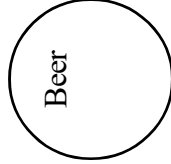

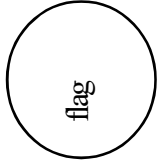


Playground

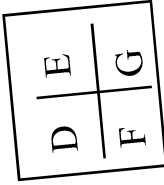

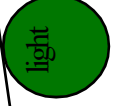
