SPACE INFORMATION: Acceptance based on available spaces in each category on a first received basis. Items being sold must be hand crafted by the participant applying for the show. New vendors, or new items for existing vendors, submit three photos of your work. You will be asked to remove Non-juried items. Apply early if you hope to get “last year’s space.” You **MUST** set up **INSIDE** your allotted 10’x10’ space. Booth must be manned during show hours (10 a.m. to 5 p.m. on Sat. and 10 a.m. to 4 p.m. on Sun.) Do not break down early. **Stakes of any type are not allowed in the park.** Weigh down your canopy and equipment, the winds in Tehachapi are unpredictable! **Do not park your vehicles along Tehachapi Blvd. during show hours.** This area is for YOUR customers. Limited security on Fri. and Sat. night. TVAA is not responsible for loss or damage to your booth or its contents.

SET UP/Teardown INFO: Fri. 2 p.m. to 6 p.m.; Sat 6 a.m. to 9:30 a.m. Drive up, unload and move your vehicle, *then* set up. Curb space for loading and unloading is limited, please be considerate of other vendors. The show committee will do their best to accommodate any special needs that you may have. Please let us know with a list on the back of your application. **Do not bring your car to the curb before the show is over.**

****INSURANCE REQUIREMENTS:** City of Tehachapi requires insurance for all vendors. You must send in your insurance certificate with the following additionally insured wording “The City of Tehachapi, its council members, officers, employees and agents 115 South Robinson Street, Tehachapi, CA 93561” (www.actinsurance.com offers vendor insurance for \$49 per 3 day event).

Do not send in your application without proper insurance certificate and fees. Email gale67@gmail.com with any questions.

AUGUST VENDORS: Vendors who participate in both of our events receive first priority for a space in the Aug. Festival.

SELLER’S PERMITS: Can be obtained from any State Board of Equalization, at no cost to you. You are responsible for any sales tax. **The \$5 City of Tehachapi Vendor Permit Fee is INCLUDED in your booth fee.**

DRESS & BEHAVIOR: We are a family oriented event. Items for sale should be family friendly. Please dress accordingly: shirts, shoes, no revealing clothing. No weapons are allowed. City ordinances prohibit pets, smoking and alcohol consumption in the park. Weather and wind is unpredictable in Tehachapi, be prepared for cold weather too!

IMPORTANT PAYMENT INFO: Confirmations by email only. Make your **non-refundable**, non-transferable check or money order payable to TVAA. Applications due 15 days prior to event no exceptions. We now have to have our paperwork to the City 2 weeks prior to our event.

Food Vendors MUST turn in their applications with Kern County Food Permit Number no later than 33 days prior to event! NO EXCEPTIONS!

Violators of these guidelines will be asked to leave and disqualified from future TVAA sponsored events.

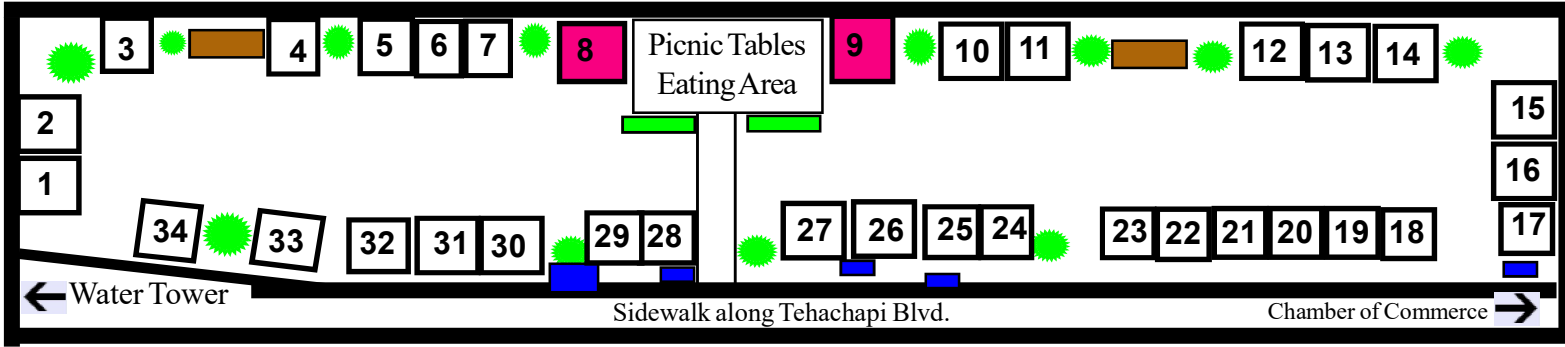

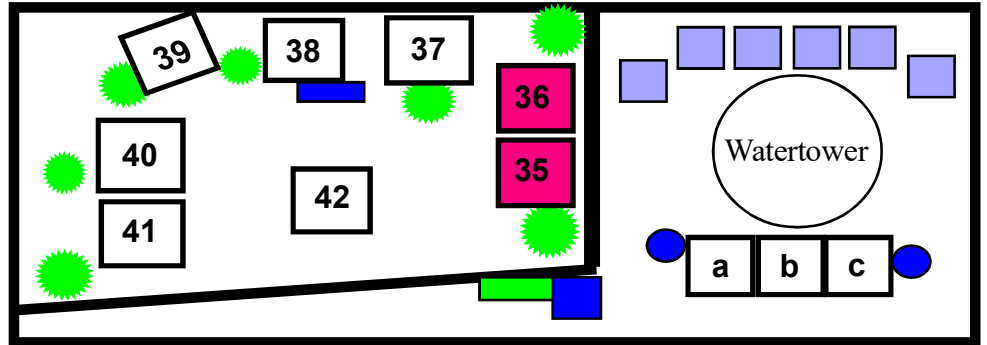
